NON-DISCLOSURE AGREEMENT

PARTIES

BETWEEN: Each person specified in Item 1 of the Schedule below (hereinafter called the "Confidant")

AND: Each person specified in Item 2 of the Schedule (hereinafter called the "Franchisor")

OPERATIVE PARTS

In consideration of the Franchisor (at the request of the Confidant) agreeing to disclose the Confidential Information to the Confidant (for the sole purpose specified in item 3 of the Schedule) which information the Franchisor regards as, and wishes to maintain as, confidential, the Confidant hereby agrees with the Franchisor as follows:-

1. all the Confidential Information will be treated by the Confidant as confidential; and
2. the Confidant will not without the prior written consent of the Franchisor:-
 - (a) by any means communicate and/or disclose and/or use and/or copy and/or reproduce and/or memorise the Confidential Information to any person without the prior written consent of the Franchisor; and/or
 - (b) divulge any part of the Confidential Information to any employee or employer of the Confidant; and
3. to return to the Franchisor all originals and all reproductions (in whatever form) of the Confidential Information that is within the possession, and/or control of the Confidant, within three days after receipt by the Confidant of a written request from the Franchisor for the return of the Confidential Information; and
4. the obligations of the Confidant under this agreement will continue in full force and effect until the Confidant is released in writing by the Franchisor; and
5. the Franchisor may obtain injunctive relief against the Confidant for any breach of this agreement; and
6. this agreement will be governed by the law of Queensland and the parties submit to the jurisdiction of the Courts of Queensland; and
7. in this agreement the term "Confidential Information" means the whole of, and each part of, any information and/or data disclosed or otherwise passing from the Franchisor to the Confidant in connection with : the Franchisor, a franchisee and/or a franchise business connected to the Franchisor (hereinafter referred to as Franchisee and Franchise Business respectively), the method of operation of a Franchise Business, and includes, without limitation, the contents of the Franchisor's operations manuals, trade secrets, drawings, know-how, techniques, source and object code, projections, business and marketing plans, contracts, arrangements and/or understandings with third parties including suppliers of either the Franchisor or a Franchisee; the financial affairs, financial condition, turnover figures and/or profitability of the Franchisor and/or Franchisee; details of the Franchisor's methods of producing, supplying and retailing the products and/or services supplied by Franchisor and/or a Franchisee to their customers, a Franchisee's customer information, formulae, customer lists, suppliers, development proposals, concepts not reduced to material form, designs, plans and models.
